^{*} The federal government sets the poverty levels every year. The 2021 FPL limits are effective January 1 for the MAGI Medi-Cal programs and April 1 for the non-MAGI Medi-Cal Aged, Blind & Disabled and the Working Disabled Program. For Covered California, the 2021 FPLs are effective at the beginning of the upcoming open enrollment period; therefore, the FPL limits in effect through October 31, 2021 for Covered California programs and credits are the 2020 income limits used during the most recent open enrollment period that began November 1, 2020. See 10 C.C.R. § 6410. Before open enrollment begins in November 2021, Covered California will release new limits here: https://www.coveredca.com/support/financial-help/federal-poverty-level/.

Notes:

- Monthly and Annual FPL Levels are rounded up to the next highest dollar. For example, 1.2 rounds up to 2.
- **Monthly income** is 4.33 times weekly income.
- For MSP applicants or recipients who receive Title II RSDI income, the effective date for the new FPLs is March 1, 2021.
- The 5% income disregard has been applied to MAGI income levels where it applies.
- For families with more than 6 members: add \$378.33/month or \$4,540/year to the 100% FPL amount for each additional person and then round up.

^{**} Pregnant people or adult & child: \$750/mo. If 2 adults, Maintenance Need Level is \$934/mo or \$11,208/year.

^{***} Beginning December 1, 2020 the limit for the Aged, Blind & Disabled Medi-Cal Program increased to 138 percent FPL. But because the program's annual FPL updates occur on April 1, until then the limits are the 2020 FPL limits: \$1,468 for an individual, and \$1,983 for a couple.
