* The federal government sets the poverty levels every year. The 2022 FPL limits are effective January 1 for the MAGI Medi-Cal programs and April 1 for the non-MAGI Medi-Cal Aged, Blind & Disabled and the Working Disabled Program. For Covered California, the 2022 FPLs are effective at the beginning of the upcoming open enrollment period; therefore, the FPL limits in effect through October 31, 2022 for Covered California programs and credits are the 2021 income limits used during the most recent open enrollment period that began November 1, 2021. ** Pregnant people or adult & child: \$750/mo. If 2 adults, Maintenance Need Level is \$934/mo or \$11,208/year.

^ Beginning April 5, 2021 (effective May 1, 2021) the American Rescue Plan expanded premium assistance for 2021 and 2022. ARPA limits a consumer's required contribution to 8.5% of HH income (effectively eliminating the 400% FPL "cliff".) However, before ARPA and beginning January 1, 2020, Covered CA provided state-funded premium assistance for those between 400 - 600% FPL. We have kept these income levels for reference.

Notes:

- **Monthly and Annual FPL Levels are rounded up to the next highest dollar.** For example, 1.2 rounds up to 2.
- **Monthly income** is 4.33 times weekly income.
- For **MSP applicants or recipients** who receive Title II RSDI income, the effective date for the new FPLs is March 1, 2022.
- The **5% income disregard** has been applied to MAGI income levels where it applies.
- **For families with more than 6 members:** add \$393.33/month or \$4,720/year to the 100% FPL amount for each additional person and then round up.
